MEDICAL SERVICES	The LOC will provide a first medical aid service, a doctor and emergency medical transportation in the competition area.												
VISA	Please verify immediately with your travel agent or the Belarus Embassy or Consulate in your country if a visa is required for your travel to Belarus. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 1 February 2018 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport issue and expiry dates, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.												
INSURANCE	The Host Federation, the Organizing Committee will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation (except for gymnasts and judges). The OC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the OC in advance.												
INTERNATIONAL TRANSPORTATION	The invited participating federations must pay for the International travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by 10 February 2018.												
ACCOMMODATION	The Organizing Committee has reserved allocations for official delegations in the following hotel: 1. Hotel Agat, Minsk, Belarus The costs per person/night are as follows: - 30 EURO in single room - 20 EURO in double room While the Accommodation Form must be returned to the OC by 1 February 2017 at the very latest, the Hotel rooms will be allocated on a "first come, first serve" basis. The invited participating federations must pay for the accommodation expenses of their delegation members. The costs for the accommodations should be paid upon arrival.
