The Technical Delegate, accompanied by the Technician of the Apparatus Manufacturer will proceed to the apparatus control in the competition hall, warm-up hall and training hall(s) prior to training and competition.

The Apparatus control includes the check of the dimensions of the RG competition floors which must respect the valid FIG Apparatus Norms. All floors must be set up correctly and the RG competition floors in the different halls must be identical.

All-Around which serve as qualification for the Apparatus Final:

All Individual gymnasts have to participate in the All-Around qualification

PARTICIPATION

Apparatus Finals:

• The top eight (8) gymnasts per apparatus from the All-Around qualifying Competition participate in the Finals

Group competitions:

All-Around which serve as qualification for the Routine Final:

• All Groups have to participate in the Qualifications

Final Group Routines:

• The top eight (8) groups of each Group Routines will qualify for the Finals.

FEDERATIONS INVITED

The Organizing Member Federation invite all FIG Member Federations in good standing.

SIZE OF DELEGATION AND FIG LICENSE

Only senior gymnasts in good standing with the correct age and holding a valid FIG License at the time of registration until the end of the competitions may participate.

No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.

JUDGES AND JUDGES' PANELS

Competitions will be evaluated by two Judges' Panels as follows:



For Individual competitions:

Per panel:

- 4 Difficulty (D) Judges min. cat. 2
- 2 Reference Judges (ETR min. cat. 2, nominated by FIG
- 6 Execution (E) Judges min. cat. 2
- 2 Line (L) and 1 Time (T) Judges min. cat. 3

For Group competitions:

Per panel:

- 4 Difficulty (D) Judges min. cat. 2
- 2 Reference Judges (ETR, technical faults) min. cat. 2
- 6 Execution (E) Judges min. cat. 3
- 2 Line (L) and 1 Time (T) Judges min. cat. 4

The Judges' Panels will be set up by a draw directed by the RG Technical Delegate from the judges present at the event. Priority will be given to the highest categories.

The participating member federations must send minimum one qualified judge if they participate with individual gymnasts and one qualified judge if they participate with a group. Those judges can be the same or different.

The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the on-line nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.

Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation.

The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge (to be paid to the LOC by **01 April 2020** should a federation fail to bring the required number of judges or judges without the requested qualification (brevet).

FIG TECHNICAL DELEGATE AND SUPERIOR JURY

The FIG Technical Delegate (President of the Superior Jury), the 6 Supervisors (Superior Jury) and the EC Members (if applicable) will be designated by FIG.

REGISTRATION DEADLINES

DRAWING OF LOTS

Registrations and payments made after the gymnasts' drawing of lots will not be accepted and the Delegations will not be authorized to participate.

The LOC will apply for the visa support letter to the Ministry of foreign affairs, after all arrangements LOC will send you the letter which should be printed and provided in the Uzbekistan Embassy in your country. If there is no the Uzbekistan Embassy or Consulate in your country you will get visa in Tashkent airport upon arrival, in this case please indicate this in the online visa application form. **INSURANCE** The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). After the deadline of the nominative registrations, the LOC will send the pin-code to each participating Federation. Heads of Delegations have to check information about their own delegation as regards of hotel reservations and payments. The head of delegation will need to bring: Passports for all delegation members Insurance for all Delegation members 2 copies of CDs with music for the programs - National flag (120 x 205 cm) - CD with national anthem Gymnasts / Groups music (CD's) – 2 (one for competition, one for trainings) In addition, the LOC will distribute information regarding gymnasts' safeguarding plan. **FINANCIAL** Federations which have not fulfilled their financial obligations towards the FIG (e.g. **OBLIGATIONS** annual membership fees, unpaid invoices, etc.) will not be allowed to participate in this World Cup. Federations which have not fulfilled their financial obligations towards the LOC by the given deadline in the Directives may still have the possibility to participate, but the LOC will not guarantee the hotel booking, meals and local transportation. Federations which have not fulfilled their financial obligations towards the Organizing Member federations upon arrival will not be accredited. **BANK ACCOUNT** Bank details as well as the contract for payment will be sent to NFs by the LOC after receiving accommodation and meals forms from the participating Federations. INFORMATION The participating Federations are responsible for covering all bank fees in connection with the bank transfers. **TIE BREAKING** In case of a tie at any place, the tie breaking rules as outlined in the current FIG Technical Regulation Section 3 for the RG World Championships shall be applied. **RULES** After application, if there is still a tie: For participation to the Apparatus Final (Individual) and Final Routine (Group): • The tied gymnasts / groups will proceed to the final. For Prize money: The prize money of the tied ranks will be added and divided by the number of ties.

For World Cup Points:

 The World Cup points of the tied ranks will be added and divided by the number of ties.

For Yearly winner (Rules for the RG FIG World Cup Series 2017, 2018, 2018, 2020):

 The number of ranks of the three counting competitions achieved by the respective gymnast/group will be added and the gymnast/group with the lowest total will prevail.

- If there is still a tie, the total score of the three counting exercises will be added and the gymnast/group with the highest total will prevail.
- If there is still a tie, the total execution score of the three counting exercises will be added and the gymnast/group with the highest total execution score will prevail.
