Make sure that your gymnasts use only FIG certified Hand Apparatus for this event and for any other FIG recognized competitions, as they will not be allowed to compete with an Apparatus which does not comply with the norms.</p> <p><b>Random checks on the FIG and Manufacturers' Logos will be carried out at any time during the Event.</b></p>

<b>GRAND PRIX SUPERVISOR</b>	The LOC, according to Grand Prix Regulations, will cover the flight tickets, accommodation, meals and 50 EUR per day including the days of travel for two official Supervisors from the Grand Prix Committee for the period of March 20-23, 2020 (3 nights).								
<b>AGE LIMITS</b>	Senior gymnasts: born in 2004 or before. <b>Only Gymnasts with the correct age and holding a valid FIG License, valid until the end of the event, may participate.</b>
