<b>JUDGES AND JURIES</b>	<p>All judges must have a valid <b>FIG Judge's Brevet Category 1-4</b> for the period of competitions.</p> <p>Each Federation must send <b>minimum 1 judge</b>.</p> <p>The fine of <b>50 EUR</b> will be applied to delegations without a judge.</p>										
<b>ENTRY FEES</b>	<b>50 EUR</b> per gymnast										
<b>ACCREDITATION</b>	<p>Accreditation of all delegations will take place upon arrival. Heads of delegation or coach have to check the names of their own delegation members, hotel reservation; they also have to effect all necessary payments.</p> <p>Heads of delegation have to bring to accreditation office:</p> <ul style="list-style-type: none"> <li>▪ passports of all members of the delegation</li> <li>▪ Medical insurance for each delegation member</li> <li>▪ a CD with the national anthem and the national flag</li> <li>▪ 2 copies of CDs with music for the programs (each gymnast)</li> </ul> <p>In order to speed accreditation procedures, please send to the LOC a <b>photo of each delegation member</b> (in electronic format) together with the nominative registration <b>before February 20, 2020</b>.</p> <p><b>Note:</b> Photos taken upon arrival shall be charged to the National Federations at a cost of <b>10 EUR each</b>.</p> <p>Accreditation card is personal for each of the delegation members. Accreditation card wearing is required at all times of the event.</p>

	<p>The Host Federation can be represented by 4 gymnasts in every age category.</p> <p>Medals will be awarded to top-3 gymnasts per each apparatus per age category. Max. 2 gymnasts per country per age category will be awarded.</p>

<b>MEDICAL SERVICE</b>	<p>The Organizing Committee will provide a first medical aid service.</p>
<b>VISA</b>	<p>Please verify immediately with your travel agent or the Ukrainian Embassy or Consulate in your country if a visa is required for your travel to Ukraine.</p> <p>The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made to the LOC before <b>February 20, 2020</b>.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: <b>10 EUR per person/day</b>.</p>
