	Aere Trampoline Cup is an event open to all clubs affiliated in their respective National Federations, as well as representatives of National and/or Regional Federations.																									
AGE LIMITS	Age Group: 11-12, 13-14, 15-16, 17-21 All participants must hold a valid FIG Licence, until the end of the event.																									
JUDGES AND JURIES	<p>All judges must have a current valid FIG brevet in the respective discipline.</p> <p>The number of Judges' panels may be decided by the organizing member federation depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw from the judges present at the event.</p> <p>Each participating federation/club must provide minimum one judge (. ENTRY FEES	<p>The cost for the entry fee is 40 € per gymnast.</p> <p>The participating federations/clubs must pay for all entry fees. At the time of the Definitive registration (2 months prior to the event) 100% of the entry fee must be paid to the OC. The entry fee is not refundable.</p> <p>Entries without payment of the entry fees will be considered as invalid and will be refused.</p>																									
ACCREDITATION	<p>Each delegation will be taken to the accreditation desk upon arrival. The following items will be checked there:</p> <ul style="list-style-type: none"> - Total payment of costs due to the LOC - Passports, Names and Date of Birth of the entire delegation - Insurance – every delegation member needs a valid insurance - Travel schedule - National anthem and national flag <p>In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.</p>																									
EVENT FORMAT	<p>This International Tournament will be run in the following two (2) disciplines and four (4) age groups:</p> <ul style="list-style-type: none"> • Individual Trampoline • Synchronized Trampoline • 11-12 years (following WAGC Rules) • 13-14 years (following WAGC Rules) • 15-16 years (following WAGC Rules) • 17-21 years (following WAGC Rules) <p>Competition will consist of Qualifications and Finals.</p> <p>Participation in the Qualifications:</p> <ul style="list-style-type: none"> • All competitors must take part in the qualifications. • No qualifications will be held if there are less than 9 participants per discipline. • In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2017 FIG Technical Regulations) shall be applied. 																									

	<p>Participation in the Finals: The top eight scores from the qualifications qualify for the finals. There will be no limits of participants per federation/club in the finals. In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2017 FIG Technical Regulations) shall be applied.</p>

VISA	<p>Please verify immediately with your travel agent or the Italian Embassy or Consulate in your country if a visa is required for your travel to Italy. The Organizing Committee will be happy to assist each delegation member with an official invitation letter, provided that the request is made before February 19th, 2020. The request must include the full name, date of birth, gender, function, passport number, passport expiry date, and the arrival and departure dates of the delegation member as well as the city the visa application letter must be sent to.</p>										
INSURANCE	<p>The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient coverage must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations' own charge as follows: 80 € per person/day.</p>										
INTERNATIONAL TRANSPORTATION	<p>The invited participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the OC by March 25th 2020.</p>										
LOCAL TRANSPORTATION	<p>Transfer for delegation members from/to the following airports are included in the hotel costs, as well as a shuttle service from hotels to venue and back. - Milan Linate (LIN) Price for transfer from Milan Malpensa Airport (MXP) will be quoted upon request depending on the number of passengers.</p>

The prices charged for the hotel rooms will not exceed the usual hotel rates. While the Accommodation Form must be returned to the OC by **February 19th 2020** at the very latest, the Hotel rooms will be allocated on a “first come, first serve” basis.

The invited participating federations must pay for their accommodation costs. At the time of the Definitive registration (**February 19th 2020**) 50% of the accommodation costs must be paid to the OC. Entries without the payment of the 50% of the accommodation costs will be considered as invalid and will be refused. The remaining 50% of the accommodation costs must be paid by **March 25th 2020**.

MEALS	Additional lunch tickets can be purchased at the venue for 20 €.
CANCELATION POLICY	The deadline for non-reimbursement accommodation, meals and banquet, is April the 1st 2020 . Rooms with half/full board cancelled until 31st of March at the very latest will be subject to a cancellation fee of 50% to be paid by the Federation concerned. Rooms with half/full board cancelled from 1st of April until the arrival of the delegations on site or “no show” will be subject to a cancellation fee of 100% to be paid by the Federation concerned.
FINAL BANQUET	Final banquet is included in the hotel prices, for those who has booked their stay through the OC. Additional banquet tickets can be purchased upon arrival for 40 €.


