JUDGES AND JURIES	All participants must hold a valid FIG Licence, until the end of the event.  All judges must have a current valid FIG brevet in the respective discipline.  The number of Judges' panels may be decided by the organizing member federation depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw from the judges present at the event.  Each participating federation/club must provide minimum one judge (. Rooms with half/full board cancelled until 31st of March at the very latest will be subject to a cancellation fee of 50% to be paid by the Federation concerned.
