	<p>For the Judges' categories, please refer to the General Judges' rules in force at the time of the event. Not more than one judge per Federation per panel will be permitted. Priority will be given to the highest categories.</p> <p>The Judges' Panels are set up by a draw from the judges present at the event. The draw will be directed by the FIG Technical Delegate on site.</p> <p>The participating member federations must send minimum one qualified judge if they participate with individual gymnast(s) and one qualified judge if they participate with a group. Those judges can be the same or different</p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the on-line nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.</p> <p>Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation.</p> <p>The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge (to be paid to the LOC by <b>17 March 2023</b> should a federation fail to bring the required number of judges or judges without the requested qualification (brevet).</p>

In order to be considered, the coach-sport profile (including all relevant documents) must be submitted in FIG Database on <b>03 March 2023</b> at the very latest (two weeks prior to the deadline for Nominative Registration).</p>															
<b>FIG TECHNICAL DELEGATE</b>	<p>The FIG Technical Delegate will be proposed by the FIG RG TC. He/she will serve as President of the Superior Jury.</p>

If there is no the Uzbekistan Embassy or Consulate in your country you will get visa in Tashkent airport upon arrival, in this case please indicate this in the online visa application form.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. <b>MEDICAL SERVICES</b>	<p>The LOC will provide a first medical aid service, a doctor and emergency medical transportation in the competition area and in the training areas.</p>
<b>COVID 19</b>	<p>As the COVID-19 situation is still under observation and unstable around the world, besides the FIG medical guidelines for the particular event, FIG also still requires all the participants to follow the standard precautions.</p> <p>The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout.</p> <p>Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible.</p> <p>Competitors arriving in Uzbekistan must fully comply with the precautions that are specified in the Regulations of the Ministry of Health of the Republic of Uzbekistan "To warn and prevent the spread of COVID-19 during the RG Competition".</p> <p>To enter Uzbekistan, each member of the delegation must have a PCR test with a negative result to be provided to the medical service at the airport of Tashkent (done no later than 72 hours before arrival in Uzbekistan).
